

# 2022-2024 Certification CME Cycle

The information contained in this document outlines the continuing medical education (CME) requirements for all AOA Board Certified Physicians (diplomates).

Diplomates of the AOA, whether holding a time-limited or non-time-limited board certification, must meet the certification CME requirements as stipulated by the specialty certifying board.

Diplomates who hold time-limited certifications must adhere to the requirements of Osteopathic Continuous Certification (OCC) Component 2: Lifelong Learning/Continuing Medical Education (CME).

The requirements listed in this document are for the purposes of AOA board certification only. It is the responsibility of the individual physician to stay informed about their CME requirement for state licensure, membership in other organizations, etc.

### **Time-Limited Diplomates**

Time-limited diplomates certified by the American Osteopathic Association (AOA) are required to meet the specified CME credit hour requirements for the 2022-2024 certification CME cycle as part of Osteopathic Continuous Certification (OCC) Component 2: Lifelong Learning/Continuing Medical Education (CME).

The number of CME credits required is determined by each specialty certifying board. Newly certified diplomates entering the program mid-cycle will have their CME credit requirements prorated.

A diplomate's CME Activity Report will outline the total CME requirement, the number of credits required in Categories 1 and 2, and any applicable specialty specific CME requirement. The chart on the following pages lists the requirements by specialty board. Diplomates who hold time-limited certifications must complete the OCC Component 2: Lifelong Learning/CME requirement in addition to all other components of OCC.

### **Non-Time-Limited Diplomates**

Non-time-limited diplomates **who choose not to** voluntarily participate in OCC will be required to complete 120 total CME credits during the 2022-2024 certification CME cycle regardless of specialty. The number of credits required in Categories 1 and 2, and any applicable specialty specific CME requirement

are detailed in the chart on the following pages according to specialty board.

Non-time-limited diplomates **who choose to** voluntarily participate in OCC are required to meet the specified CME credit hour requirement for the 2022-2024 certification CME cycle as part of Component 2: Lifelong Learning/Continuing Medical Education (CME). The number of CME credits required is determined by each specialty certifying board.

A diplomate's CME Activity Report will outline the total CME requirement, the number of credits required in Categories 1 and 2, and any applicable specialty specific CME requirement. The chart on the following pages lists the requirements by specialty board. Diplomates who hold non-time-limited certifications and are voluntarily participating in OCC must complete the OCC Component 2: Lifelong Learning/CME requirement in addition to all other components of OCC.

### **Specialty-Specific CME**

Active AOA specialty certifying boards may choose to require diplomates to obtain specialty specific CME during the 2022-2024 certification CME cycle. Refer to the chart for the requirements of each specialty certifying board.

Dormant specialty certifying boards or active specialty certifying boards with subspecialty certification(s) in dormant status require diplomates to obtain specialty specific CME during the 2022-2024 CME cycle. Refer to the chart for details of the requirements for boards and/or subspecialty certifications in dormant status.

## **Conjoint Subspecialty Certifications**

Conjoint certifications are subspecialty certifications. As such all conjoint subspecialty certification holders must abide by the requirements of their primary specialty certifying board. No additional CME is required to maintain a conjoint subspecialty certification.

The AOA assigns CME credit to four categories: 1-A, 1-B, 2-A, and 2-B. In very general terms, Category 1 is typically osteopathic CME; and Category 2 is typically non-osteopathic CME. Category A is usually live activities, and Category B is not (with a few exceptions).

If there is no specific cap on an activity noted in the "Rules, Caps, etc." section, there is no limit to how many credits a physician can earn from that activity during the 2022-2024 certification CME cycle.

### **Reporting CME Activities**

Transcripts from other institutions (hospitals, CME trackers, etc.) will also be accepted if it contains the total number of hours.

AOA board certified physicians are responsible for keeping abreast of the rules and regulations of CME.

### **Initial Certifications**

When a physician first becomes certified, their CME requirement will be prorated for the current board certification CME cycle only. Prorations will be based on the date of certification, as follows:

#### **Reactivated Certifications**

When a physician reactivates an expired/inactive certification, their CME requirement will be prorated based on the amount of time the certification was inactive, as follows:

BOS approved reductions/waivers in the number of required CME credits for certification do not affect individual state CME licensing requirements. The BOS will not consider reductions/waivers of CME credit hours without due cause unless policy advises otherwise.

**CME reductions and waivers granted for the current Certification CME Cycle only.** Requests must be received prior to the end of the 2022-24 Certification CME Cycle on Dec. 31, 2024. If a diplomate submits a certificate of completion for participating in a standardized life support course the number of CME credits indicated on the certificate will be recognized by the AOA. In cases where the certificate of completion does not contain a specific number of CME credits, CME will be awarded based on the chart listed below.

Diplomates who teach a standardized life support course and submit a certificate or teaching log will earn CME credits on an hour-for-hour basis. In cases where the certificate or teaching log does not contain a specified amount a maximum of ten (10) CME credits may be awarded per calendar year.

Physicians who hold active certifications in these specialties/subspecialties will have the following CME requirements:

- 120 total CME credits per 3-year certification CME cycle
  - Of the total 120 CME credits required, a minimum of twenty-five percent (25%) must be specialty-specific.
    - Specialty-specific CME will be verified by the diplomate via a self-attestation form, subject to random audit by the AOA.
